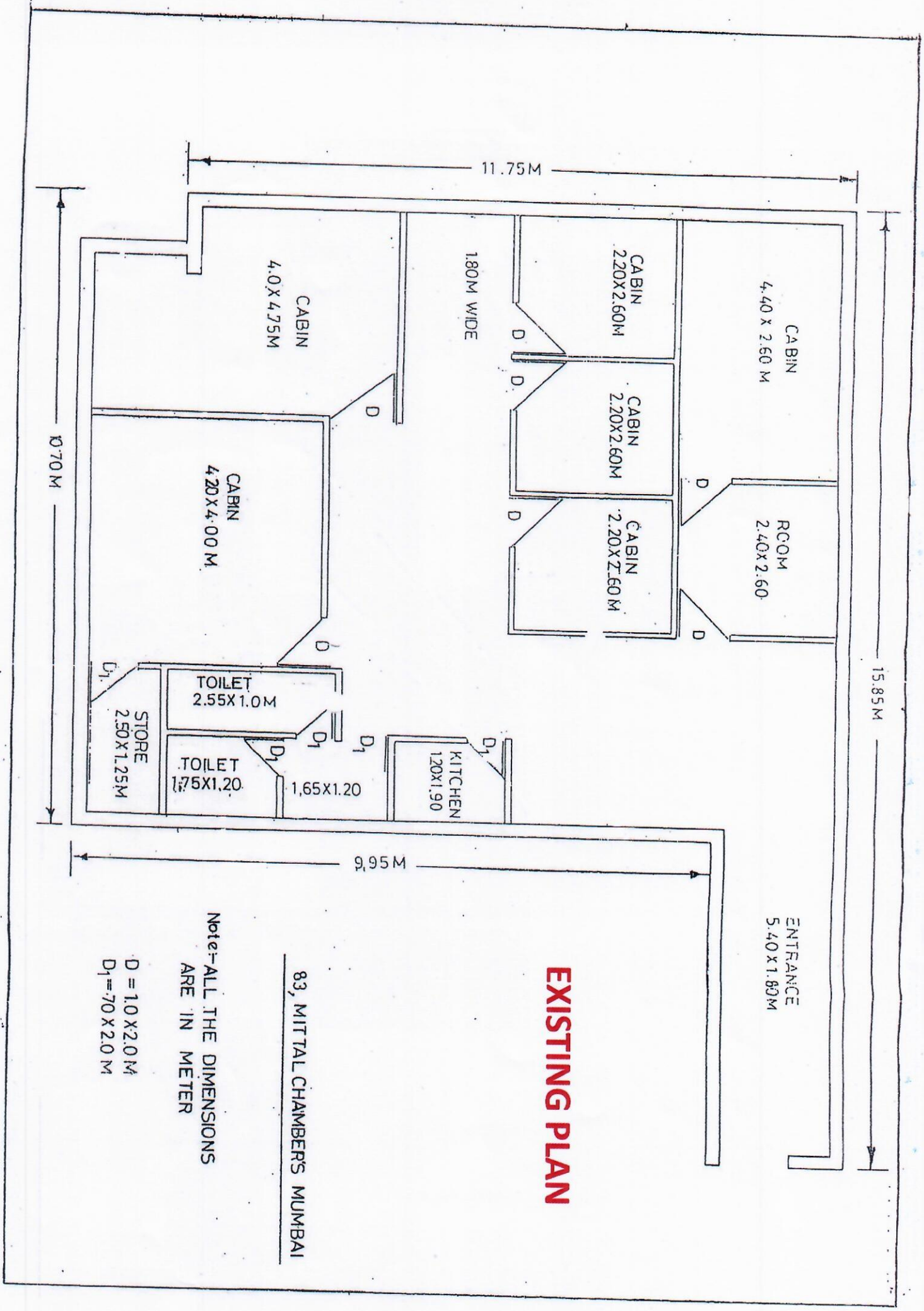

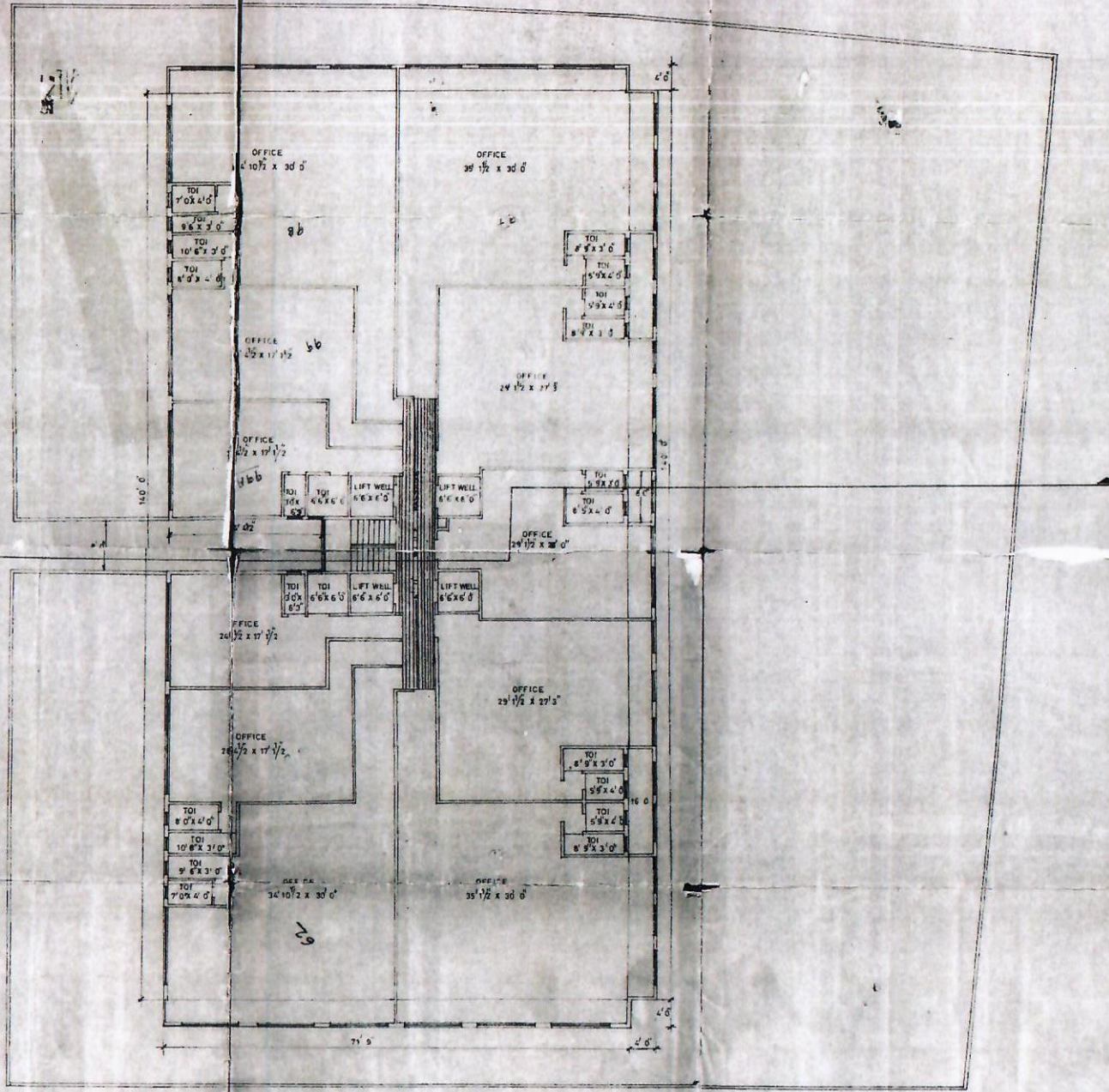


EXISTING PLAN
